## 4. APPLICATION / LIMITATION :

4.1 - The navigation lights shall be equipped with lamps of an approved type such that their application will result in the same luminous intensity distribution and chromaticity, as the lamp used for the prototype test. Furthermore they shall be compliant with all applicable vibration and shock testing requirements as per EN 14744 as well as all environmental test requirements as per EN 14744.

4.2 - For all seagoing vessels with a length of less than 20 meters.

## 5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type. #### **<u>6. MARKING OF PRODUCT :</u>**

Reference is made to MED 2014/90/EU chapter 2.

In particular Article 10.3 specifies that the wheelmark shall be followed by the identification number of the Notified Body involved in the production control phase (module D, E or F) and by the year in which the mark is affixed (4 digits or last 2 digits).

In addition, each navigation light shall be marked permanently in a position clearly visible even after installation on board, with the following information:

6.1 - Zero signal direction by a mark on the reference circle lights

6.2 - Range in nautical miles

6.3 - Origin mark (manufacturer's identification mark)

6.4 - Type designation.

6.5 - Nominal wattage of the light source in watts, if different values lead to different ranges.

# 7. OTHERS :

7.1 - It is **Metaalwarenfabriek Den Haan Rotterdam B.V.**'s responsibility to inform shipbuilders or their sub-contractors of the proper methods of fitting, use and general maintenance of the approved equipment and the conditions of this approval. 7.2 - This Certificate supersedes EC Type Examination Certificate No. 11439/C0 EC issued on 21 Nov 2019 by the Society.
